The GFWC Georgia President's theme for 2024-2026 is "Hand-in-hand, together we can...engage, educate, empower," using a circle of hands to symbolize the importance of combining our volunteer efforts to serve our communities. The premise is simple: as volunteer clubwomen, we can do so much good with our hands – create art, feed the hungry, pick up trash, hold a book and read to children, comfort the sick, protect the helpless, vote, or write a check. Our two hands can do a whole lot of good. But together if we multiply that one pair of hands by five or twenty or fifty times, just think what we can accomplish!

The Special project adopted for this administration is focused on literacy and is entitled "Books for Little Hands." GFWC Georgia club members embraced the project in many creative and effective ways such as stocking new or existing Little Free Libraries, collecting and cleaning gently used books for distribution to hospitals and schools, filling baskets with books at Easter and Christmas for foster children, and establishing a reading corner at a local laundromat. Two clubs co-sponsored a Taste of Chocolate event, earning over \$9000 to purchase books through the Ferst Foundation. Clubs partnered with police departments, schools, advocacy centers, public libraries, physician's offices, health departments, childcare centers, and shelters to provide books for children. Over 12,400 books were distributed to little hands in Georgia's communities.

This administration's special project for Tallulah Falls School is to purchase a cellular gate access system which will allow the authorized administrators and security personnel to use phone devices or web-based interfaces to remotely open the gates for visitors. To date, clubs have contributed over \$1100 to this cause.

To promote the use of hands in all areas of work, members were issued the President's Hands-On Challenges. For example, "Crafted by Hand" encourages members to host a craft booth at a community event. Other challenges include "Lend A Hand" to a veteran, "Get Your Hands Dirty" by picking up trash, support "Healing Hands" at hospitals, endorse the "Business At Hand" by voting, or help the "Hands That Rock the Cradle" by supporting a child advocacy center. Members are excited by these and other challenges for all the CSPs, Advancement Areas and Special Programs.

As our members think of ways to use their hands, we turn to our leaders for guidance. Georgia is fortunate to have legacy leaders whose guiding principles, core values, and integrity guide us. This administration is utilizing a top-down, bottom-up shared leadership model, where State leaders facilitate continuous learning, encourage autonomy, provide constructive feedback, and reward success. Leaders reinforce the connection between our clubs, our Districts, the State, and as an extension, our Region and International counterparts, so that members understand

the impact of our organization. State and District meetings are opportunities for members to engage with Federation sisters, learn new skills and share a common purpose.

Plans for the new administration began In February 2024, at a weekend retreat for officers at the Lipscomb Cottage. It was an opportunity for the group to bond and discuss strategies for improving GFWC Georgia. Job descriptions were created for all positions on the Leadership team, tentative schedules were set, and a shared vision was adopted. Once appointments for the new administration were completed, the new leaders and officers attended an all-day orientation in April to meet other members of the Leadership Team and learn about their respective responsibilities. "Hand-in-Hand: Engage" introduced the Leadership Team to the President's vision and provided job descriptions. "Good Leaders Defined: Educate" activities included duties of the Leadership Team, protocol matters, "Talk to the Hand" (strategic planning), and "What's Your Why." The "Build Your Team: Empower" session afforded committees time to collaborate with members and make plans.

After installation at the Georgia Convention in late April, the Leadership Team was busy, gathering information to write Georgia's plan of work. Each section contains suggestions for projects to coincide with GFWC programs and emphasis areas, including Community Connection Initiatives, the State President's Hands-on Challenge, affiliate organization information, special monthly observances or dates to remember, and Georgia Bylaws and Standing Rules. Once chairs completed their sections, a Proofing Palooza was held at the lakeside home of the 2nd Vice-President to edit the plan of work. The 350-page Yearbook was published in print-form or on a thumb drive for purchase by members and distributed at our Summer Institute. Later in the fall our state yearbook was uploaded to our GFWC Georgia website, giving all members access to the information in digital form.

Georgia's Strategic Planning Committee began the process of updating our long-range plan. A virtual meeting was held with GFWC 2nd VP Jolie Frankfurth for guidance. As a result of the committee's study, proposals were submitted to the Bylaws Committee to update the responsibilities of elected officers and revise the structure of the Strategic Planning Committee. The Georgia Junior Conference appointed a committee to study trends and make decisions regarding the future. Subsequently, recommendations for amendments to the Bylaws were suggested in regard to Junior Conference roles and responsibilities. All proposals were reviewed by the Bylaws Committee and recommendations were sent to all members for consideration with the Call to the 2025 GFWC Georgia Convention.

The Membership Committee held a retreat in May 2024 to discuss ways to retain and recruit members. Using a Nancy Drew theme, the members of the committee began thinking of ways to unlock the mysteries of membership. Statistical information and trends over the last ten years were studied. Clubs with ten or less members were put on a "watch" list. T-shirts were printed for the Membership Committee to wear at State meetings. Skits were written by committee members to present at District and State meetings to emphasize the importance of being a GFWC Georgia member. To encourage club members to attend State events, a Send-A-Sister Scholarship was developed, and funds were included in the budget. This scholarship provides twelve \$50-stipends for members to attend both the Summer Institute and

Convention during this administration. Georgia is proud that our membership increased by 119 members from 1509 to 1628 in the year 2024.

Georgia's LEADS workshop was held the day prior to our Summer Institute in August. Fifty-five club members attended a day-long training session, exploring ways to become effective leaders in their club and community. The theme focused on the 6 E's of Leadership which included: (1) Envision – GWFC history and What's Your Why; (2) Engaging – conflict management and volunteering; (3) Educate – parliamentary procedure, protocol, and club positions; (4) Enable – leadership notebooks; (5) Empower – delegating and how to volun-tell the right way; (6) Execute – putting plans into action and utilizing skills learned.

Using the theme "GFWC Georgia On My Mind," the Summer Institute began with the GFWC Georgia State Fair where our CSP, Advancement Area and Special Programs showcased their programs/projects of work. Members circulated among booth spaces featuring each program area. Booths sported tri-boards filled with colorful information including brochures and swag obtained from affiliates. Chairmen dressed in costumes or coordinated outfits and provided fun activities to engage and educate participants about each program area. Think Carnival games with a GFWC Georgia twist! Members played area-specific games such as Throw Your Hat in the Ring Legislative Toss, Nutrition-packed Pick-up Ducks, Strategic Planning Cupcake Walk, Leadership Yatzee, Wheel of Fortune Arts & Crafts, or Continuing Education Corn Hole. Members won tickets to spend at the prize booth where GFWC Georgia- branded items were awarded. Later that afternoon, chairmen hosted break-out sessions to explain their plans of work and afford members the opportunity for Q and A. General sessions were also held (1) to review Georgia's online reporting, (2) to teach members about Georgia's new reporting AP called Track It Forward, which enables members to record live data (# members & hours) during projects, and (3) to give tips on maneuvering the Google drive. Featured speakers included our GFWC LEADS candidate, the Executive Director from the Georgia City Solutions & the Mayor's Book Project, and the director of a child advocacy center.

The fall brought District meetings and other opportunities to share information with Georgia club women. Virtual webinars were held to educate club members about our online reporting system and to assist our chairmen with preparations for judging the reports submitted by clubs. Face Book pages were created or updated for our program areas to disseminate timely information or provide project ideas. The State Newsletter, which is issued quarterly, provided reports from officers and chairmen, as well as reminders about GFWC and GFWC Georgia events and pictorial scrapbooks showing our members in action. A monthly "Connections" newsletter is published to remind members about special days or projects that may coordinate with specific months, such as National Day of Service in September, Child Advocacy Week in October or Wreaths Across America in December.

Approximately 90% of Georgia clubs participated in the National Day of Service. During our Summer Institute, any club that had registered their intent to participate by that date was entered into a drawing for a monetary award to be used as seed money for their project. Also, members were given a disposable spoon labeled with NDOS dates as a reminder to participate. Clubs supported local food banks at churches, shelters, or schools. Members filled Little Free

Libraries with non-perishable food, served meals at homeless shelters, filled backpacks for children, donated money for school lunches, packed a pantry for an automobile accident victim, and solicited donations from their communities. There was a "soup swap" where a bowl of homemade soup was provided for a donation of canned soup and an "empty bowl" luncheon with hand-painted bowls used as gifts for guests. There was even a scarecrow entry at a community event using a food insecurities theme.

The 2025 Georgia Convention was held at the Legacy Lodge on Lanier Islands near Buford, Georgia.

Over 125 members attended the three-day event hosted by the North East District which used the theme "Changes of Latitude – Changes in Attitude." The NE District clubs chose to support organizations in the area in lieu of door prizes which showed our hearts of caring. Jimmy Buffet music and tropical décor encouraged a more relaxed atmosphere as members visited, laughed, sang and danced. After careful consideration and some debate, members approved many amendments to our Bylaws that will help us better complete our business in the future. Fundraising netted over \$4000 from 50/50 drawings, GFWC Georgia-branded items, District baskets and a silent auction. The Songs You Know By Heart Lip Sync Battle was a hoot and raised over \$1600 for The Cottage, a sexual abuse and child advocacy center in Athens. A very touching Memorial Service was conducted to remember our Federation members who passed away during 2024. GFWC Georgia was proud to present a charter to our newest club, the Lake Lanier Woman's Club. Awards were presented in all Community Service Programs, Advancement Areas and Special Programs.

GFWC Georgia clubwomen have used their hands to do a lot of good work during 2024. They have embraced the President's vision that hand-in-hand, together we can!

Reviewed and submitted all GFWC Georgia reports to GFWC.


Created a Top Projects booklet of reported projects.

Four out of our six districts increased membership, as well as the Junior Conference. As a result, we increased membership by 119 members. While unfortunately we lost one club in 2024, however on a positive note we did gain one new club.




The membership committee started the administration off with a weekend retreat at the State Office to talk about the issues of finding new members, retaining current members and bringing back lost clubs. District First Vice Presidents and Junior Directors at their district meetings reported on membership and performed membership-based skits to encourage growth in our organization.

Incentives to increase membership attendance at our state meetings were provided at both the Institute and at the Convention. These included offering two "Send a Sister Scholarships" to

each district and recognizing First Time Attendees. Also, a financial incentive to encourage clubs to register for the GFWC National Day of Service was awarded at the Institute.

Finally, the Membership Team recognized all the National Day of Service club participants, club milestones, and 50 + years members. I as well as the Membership Team are looking forward to the second half of the administration.

There are 9 Junior Clubs and 139 members in the State of Georgia. The State of Georgia has six districts with 5 districts having at least one Junior Club. I have attended at least one meeting at each District since taking the position of Junior Director Elect, expect for the North East District. Since being installed as Director of Junior Clubs, I have attended three additional District meetings in the Fall 2024. I was scheduled to attend the North East District fall meeting, but Hurricane Helene kept me from attending. However, I will attend the March 29, 2025 North East District spring meeting. Since I have attended 2024 State Convention and Institute, I have met with members of each of the 9 Junior Clubs. In addition, I have attended meetings of 3 Junior Clubs since installation and attended projects at two clubs. I have also attended 2024 GFWC Convention Chicago, 2024 GFWC Board of Director Meeting in DC and 2024 Southern Region Conference.

Membership increased 18% from 118 members in 2024 to 139 members in 2025. The Junior Conference completed 437 projects totaling 10,584 hours with \$86,333 donated and \$33,240 in-kind donations. The perpetual scholarship in honor of the Junior Conference, "Dollars for Collars," has received \$2,832 of the \$5,000 goal. Fundraising has totaled \$1,388.30 since installation in April 2024.

Regarding Advocates for Children, the greatest work that was accomplished as Director of Junior Clubs in 2024 was at GFWC Georgia Institute. Since the Advocates for Children Chairman is a Junior, she and I set up the fair booth with a peg board game, informative flyers and pinwheels. The pinwheels were given as a prize for anyone that left less than 3 pegs, and boxes of pinwheels were provided to clubs for Child Abuse Prevention Month in April. The booth was decorated with pinwheels, colorful ballons and an Advocates for Children banner.

On Saturday afternoon, the Domestic Violence Chairman and Advocates for Children Chairman held a breakout session. At the breakout session, a game was played, and information was provided about projects that support both Advocates for Children and Domestic and Sexual Violence Awareness and Prevention. That evening, GFWC Georgia and GFWC Georgia Junior Conference held a joint Pajama Party. Admission into the pajama party was either a children's book or a pair of pajamas. The items were collected for Lilypad Child Advocacy Center. The center provides free services to victims of sexual assault. GFWC Georgia donated over 590 books and 168 pairs of pajamas to Lilypad Child Advocacy Center.

Sunday morning at GFWC Georgia Institute began with the Junior Conference Board Meeting. That morning, I presided over the meeting, and I had three workstations for the Junior Conference to complete projects for Advocates for Children. The three stations were worry stones, painted rocks and buttons. After the Junior Board Meeting, Mary Fabrizio, Lilypad Executive Director spoke at the closing of GFWC Georgia Institute.

At Southern Region, Juniors raised money for Camp Greenville at a Pajama Party. Initially, the monies raised would fund a camper, but Hurricane Helene severely damaged the chapel. Michelle Blackman, South Carolina Director of Junior Clubs, decided to donate the money to repair and clean up Camp Greenville from the damage caused by the hurricane. The pajama party raised \$1,600 for Camp Greenville.

Regarding the support of Advocates for Children in the State of Georgia, GFWC Georgia clubs executed 87 projects, representing 1,130 hours, donated \$4,656.88, raised \$8,442.67, spent \$5,924.93 and provided \$13,927.55 in-kind donations.

The GFWC Junior Conference is represented in the Georgia Clubwoman in each publication. The May 2024 Georgia Clubwoman article provided detailed information about my administration, and the December Georgia Clubwoman highlighted with accomplishments of the Junior Conference in 2024. The September 2024 issue of The Georgia Clubwoman detailed the highlights of GFWC Georgia Institute. The March 2025 Georgia Clubwoman article has been submitted, and it focuses on GFWC Georgia Convention 2025.

This administration was charged with working "Stronger Together" from the moment of installation. GFWC Georgia President, Cathy Jones, and I met prior to convention last year and agreed that we would serve as a unified team for the 2024-2026 GFWC Georgia Administration. The unified team was agreed upon prior to the vote concerning the GFWC Georgia Junior Conference that was held at GFWC Georgia Convention in April 2024. The vote for the dissolution was opposed; however, GFWC Georgia Juniors were charged with presenting a new set of bylaws to the GFWC Georgia Bylaws Committee by December 2024. Immediately after convention, a committee was selected to work on the bylaws led by Becky Bolden. The committee worked diligently over the last year to present bylaws that reflect the GFWC Georgia Junior Conference and the work that we want to accomplish. The Junior Conference is proud of the work that has taken place, and the committee is confident in what has been presented to the GFWC Georgia Bylaws Committee. This work is truly an example of how a group of women can come together and present a path for the GFWC Georgia Junior Conference to exist for many years to come.

Cathy and I have taken the "Stronger Together" initiative to the GFWC Georgia State meetings. At GFWC Georgia Institute, we held a joint Pajama Party. The Pajama Party featured bingo, snacks and prizes. At GFWC Georgia Convention in April 2025, we will hold a joint Lip Sync Battle. The proceeds from the Lip Sync battle will benefit a local children's advocacy center in the Northeast District where convention is being held.

February 2024 through State Convention 2024

Key accomplishments:

The fall meeting I limited "live" report to 2-3 minutes as many officers and chairmen could provide their report information in the newsletter. This helps in 2 ways: all members can read the newsletter article and it is posted to the NW District website for future reference in contrast to only members attending the meeting hearing the live report. I printed a few copies of the newsletter for the fall meeting and they were all taken in a few minutes demonstrating the high level of interest in the newsletter information.
- Both the fall and spring meetings were adjourned by 1 pm. For the fall meeting lunch was served after the adjournment of the meeting and members could leave after lunch. For the spring meeting we served "brunch" instead of lunch and the meeting and brunch were finished at 1 pm. The feedback on having brunch instead of lunch was positive. Helps keep budget of \$25 per person and allows more time for agenda items.
- Conducted several reporting workshops via Zoom prior to the January 25 deadline. One workshop included a demonstration on how to complete the reporting forms. I shared my screen and demonstrated how to complete the forms. This is significant as there were many questions that revealed lack of understanding of basic aspects of the reporting system. Feedback from members on the workshop was very positive. One club was very reluctant to report and I worked with them with repeated calls and follow up. Because of my attention and encouragement, the president did complete reports. The result was the club was recognized at the March district meeting with a club award. The president came up to me and said "I do not know how to thank you for your help. You have inspired us to report even more of our projects next year."
- Added fun to Fall meeting with music bingo and prizes. Members loved this and kept the mood upbeat.
- Collected books for little hands at the Fall meeting for local charity in LaFayette. Monetary donation from winner of 50/50 to Wellroot Family Services for books for little hands.
- March 2025 -Spring meeting: Collected baby items for Jack's basket value of approximately \$2200 - \$400 in monetary donations to Down Syndrome Association of Atlanta.
- Completed NW District Yearbook and distributed copies at February 15, 2025 board meeting.
